A Queanbeyan firm of design and build, visited. Following this, it was agreed that they would return and make a presentation. This transpired after which we engaged them execute a concept design for us. It cost us a lot of our hard-earned but failed to impress.

Now, with the extensions complete and most of the associated physical demands placed on staff and volunteers behind us, the time to get serious about dissplay was on us.

We had resolved that we would borrow a substantial sum to bring about a rapid resolution to our plans. In late 2021, at our request, Bega Valley Shire Council, it would stand as our loan guarantor. This was to enable us to negotiate such a loan. However, what with covid still rampant, interest rates rising rapidly, not to mention the geo-political upheaval in the world, we prevaricated. As the months of 2022, ticked away, an no improvement in sight, we shelved that idea and decided to proceed as our own funds would allow. Council has been informed of our decision and thanked it for its offer.

Which brings us up to the present.

The way I read Greg' proposition that his work would cover a period of sixteen weeks. If we accept the quote, it would take us to December. So as that time of the year is always lost into the summer torpor, on the one

The brief includes; making recommendations regarding the design with care for space, traffic environment etc.; Choice of artifacts ; presenting current technological opportunities; particular attention to traffic flow, explanation of the visual identity of the exhibition ; provide aesthetic guidelines and visual examples to guide the design, fully making use of digital exhibition components.

The Board will consider the foregoing at the August meeting and will, no doubt, make a decision it considers most appropriate for EKWM.

Along with those documents I delivered the records of the history of the building contract and associated document. This is a most important requirement of the Government grant agreement which will cause the final payment to be released to us. It is some tens o thousands of dollars, which, with the possible expenditure what is on the Board's August agenda, will be very timely to receive.

Many thanks to Barry Hughes for the compilation of necessary documents requird fo acquittal of the BBRF grant and to Ben, for those few that needed to be added.

The certificate that allows occupation was one of the "must haves" before the final submission to the grant department handling this offer. The bureaucratic necessities, can make the casual respondent to despair, probably more so if you happen to be that innocent abroad, and a volunteer.

While we were waiting for said document to materialise from Council, notice was received that the NSW Department of Planning had issued such document. After cooling our heels for another few weeks, enquiries resulted that the Department's certificate encompassed the BVC's own and no further documentation, on that matter, was required.

So, as it turned out, the inspection was carried out on the 2nd June, and the certificate issued on he 25th July. Bad luck if you had a business and happened to waiting on such a brief to get back into making a quid.
